## 1. CANAL - MEADOWS ROUTE Consultation ends 24 Oct + Drop-In Session 2 Oct

Edinburgh Council has published for public comment its detailed plans on the above route, due for construction in 2015/16. This follows a workshop earlier this year, attended by Spokes and other relevant local and city-wide interests, looking at main options for the route. We haven't yet scrutinised the new plans in detail, but overall they look very positive, with segregated cycleroutes on the main-road sections, and the closure of Tarvit Street to through motor traffic. There is also a **drop-in session** at <u>Barclays Church</u> (Pillar Hall) on Thursday 2 October 2014 between 4pm and 8pm where you can see large-scale plans and discuss them with the Council's project team.

Meanwhile after a positive consultation on the **Meadows-Innocent** plans we expect to see construction in Spring 2015...

### 3. 20MPH CONSULTATION - ends 17 October

Edinburgh City Council is consulting on widespread 20mph implementation within the city, following the success of the South Edinburgh wide-area 20mph scheme. The City's plans are well ahead of most (all?) other UK cities as they include not only residential and shopping streets, but also other streets if used by significant numbers of pedestrians and/or cyclists. However there is certain to be heavy opposition to some of the proposals – indeed the Evening News said it is "expected" that some streets, such as Leith Walk, will remain at 30mph despite being at 20mph in the consultation. Therefore if you support the proposals – or want them extended further – it is really important to respond to the consultation using the online questionnaire and/or by email. The public meetings and exhibitions are now all finished.

#### 6. ROADSHARE PETITION

Spokes supports the campaign for 'presumed liability' so that a cyclist or pedestrian injured in a crash with a more powerful vehicle would normally not have to go through a lengthy legal procedure to receive compensation for injury and damage. This is the normal position in almost every other European country and is quite separate from the question of criminal liability for the crash. The Roadshare campaign has recently highlighted this in the tragic context of 3 cyclist deaths on 'A' roads in Scotland in September...

## 10. FORTRESS WAVERLEY - email your MSPs if you've not yet done so

Several MSPs and MPs are taking up our concerns over Network Rail's Waverley Station cycling ban on the entry ramps - forcing bikes, pushchairs, luggage and large numbers of commuters and tourists onto the narrow footways whilst the wide adjacent roadway is vacant. The story has now also reached The Guardian – our website news item below includes a link to the Guardian story.

If you are affected, please do contact your MSPs – the more emails the better! Our member **Mark Lazarowicz MP** has received a hint that they may consider changing delivery arrangements to the station, which could then allow better cycling and walking access from Waverley Bridge. It is very important that we keep up the pressure on this to get real change.

## 12. REGULAR VOLUNTEERS - you?

We still need a 'regular' volunteer for the task below. This is really important to enable Spokes to function effectively...

- The person who handles email to the spokes address is wanting a change, so we need someone to take over this important and responsible task. Obviously a handover and advice can be provided. If possible we need somebody who has been a member for a while and who expects to be able to do the job for some time. Ideally (but not essential) also willing to attend *either* Planning *or* Resources group (every 3/4/5 weeks), to be in good touch with spokes activities. The task involves passing on emails to the relevant person/group as appropriate, and also responding directly to some enquiries, ensuring that people contacting us are not left without a reply for longer than necessary we may be able to prepare some model answers for common queries.
- We also need one or two people to join Resources Group. We organise stalls, public meetings and other events; sometimes do a lot of paperwork; and take on occasional projects such as our factsheet on cycle storage for tenement dwellers, or our forthcoming video on bike awareness for motorists. We meet roughly every 3-4 weeks.
