PRINCES ST FUTURE

Thank you to the many Spokes members who contacted their councillors in response our urgent email circular of 2 June about the proposed bike ban in the Princes St traffic-free area. The council has postponed a decision until August. We know no more yet than in our June 16 article at *spokes.org.uk*.

HOW YOU CAN HELP

- ◆ If you have not written to your councillors about Princes St, please do so, telling them what you would like to see and why.
- If you bump into a councillor, for example at a meeting, collar them, ask what is happening and tell them what you want to see.

STOP PRESS - GEORGE ST / FESTIVAL

The council has announced that during the Festival George St will be entirely closed to traffic on one side [edinburgh.gov.uk, July 4] news]. In principle this is great, but we note that there is no mention of cycling, whilst it seems that full car parking will be preserved. Since the traffic-free side will contain tents and festival events it seems likely that cycling will be only possible as part of the general traffic flow, and so only one-way. This adds weight to another of our many concerns about the proposed ban on 2-way traffic-free Princes St cycling – any future George St cycle facility might be closed during events such as the Festival and Hogmanay, leaving Queen St and Rose St as the only cycling options.

SPOKES NATIONAL CYCLING PROPOSAL

please help!! [by 23 July]

The Scottish Government is preparing NPF3, its National Planning Framework, which will include a series of 'projects of national significance'. Spokes has proposed a national project comprising one cycle-friendly town in every Scottish council area, all linked by an enhanced national cycle network. Several other groups, such as Transform Scotland, submitted related ideas.

We put forward similar ideas some years ago for the earlier NPF1 and NPF2, but our ideas were rejected. This time, however, things look somewhat more hopeful - the government has in their latest draft NPF3 document provisionally accepted the idea of the national network - but largely as a tourism/leisure project whereas our proposal is geared to kick-start everyday cycle use in every part of Scotland, on top of the benefits for tourism and leisure.

A further consultation is now underway and, encouragingly, there is a question asking if higher priority should be given to boosting everyday cycle use (and walking).

HOW YOU CAN HELP

Please make your own response to the consultation - this will be really helpful! Welcome the inclusion of a national cycle network project but urge, as proposed by Spokes, that it is widened into a national initiative to boost everyday cycle use throughout Scotland as well as encouraging more cycle tourism and leisure.

4000 PEOPLE: no problem

An imaginative letter from Dave Holladay appeared in several papers following Pedal on Parliament 2103...

The delivery of at least 4,000 people to the Meadows in less than an hour, without gridlock, or parked cars blocking the streets, and the equally silent and invisible evaporation of the crowd from outside the Parliament at Holyrood makes a clear point about why we need to promote cycling for local journeys in towns and cities. Would we need to spend huge sums on by-passes and relief roads if transport policy planned for more local trips by bike?

The Belgian city of Hasselt, taking this line, cancelled the building of a relief road, ripped up tarmac and returned the inner ring road to its former state as a tree-lined boulevard. Rental values for commercial property went up and local tax revenues rose but the council's borrowing was reduced (no longer needed to build the roads), so it moved closer to balancing the books.

Even ScotRail delivered, as the numbers heading back by train (having cycled from Glasgow, Fife and further afield) had melted away by 7pm, soaked up by well-managed loading of the trains.

Effectively managed and executed by the Pedal On Parliament team and cycling police officers, it was a great day.

July 23 Leith Walk – exhibition / consultation

Exhibition 2-8pm, McDonald Rd library. Revised plans for Leith Walk in early June were a big improvement, but left scope for further beneficial changes which were suggested by Greener Leith and supported by Spokes. Unfortunately there are *rumours* that subsequent changes have if anything moved backwards. We will find out at the exhibition: *please attend and leave your comments*.

July 24-25 Fountainbridge plans - exhibitions 13/02177/PAN and 13/02182/PAN

PAN 2177 is a mixed use masterplan covering the eastern half of the currently derelict cleared site between F'bridge and the canal, bounded at the east end by Edinburgh Quay.

PAN 2182 has more detailed proposals, including an 'aparthotel', commercial etc and is for part of the same site, bounded by the canal and Edin Quay, but not extending as far as F'bridge.

- · Good access from the canal

HOMELESSNESS TOUR

We get many requests from charities to publicise sponsored rides etc, and usually can't do so, but we're giving a special mention to this one as it is particularly imaginative and bold.

Matt Fountain from Glasgow hopes to raise £100k for Shelter by cycling 2,000 miles around Britain, carrying all equipment on the bike, using a tent most of the time and sleeping rough other times. The route is designed to include areas most at risk of eviction and homelessness, where Matt will be talking with residents.

Matt is working with Natalie Byrom, of Warwick University Centre for Human Rights in Practice, to write a book from the ride

CAPS: CYCLING ACTION PLAN FOR SCOTLAND

The new CAPS2013, as expected, is something of a damp squib, with no new funding allocated, and therefore absolutely no hope to achieve the government's 'vision' of 10% of all trips by bike in 2020. Government cycling investment is around £20m p.a. yet they plan to spend £3000m each to dual the A9 and the A96.
