Following on from their research, the *Understanding Cycling* team [from Lancaster, Leeds and Oxford Brookes Universities] made seven policy recommendations, including...

- ◆ fully segregated cycle routes on main roads in urban areas
- ◆ restrictions on car parking, speeds and access on other roads
- ◆ changing the system of legal liability, to protect cyclists and pedestrians (the most vulnerable road users) as in most Europe
- ◆ using planning legislation to ensure facilities are more local and to deter out-of-town centres
- ◆ campaigns to promote cycling and walking as 'normal,' not just for the super-fit or the dedicated.

## CANAL : lots happening

- ◆ **PAN exhibitions on Mar 20 and 27** [see opposite] about forthcoming major developments adjacent to the inner canal.
- ◆ The **Fountainbridge Canalside Initiative** is working hard for people-friendly development in the area, and particularly in the 14/00309/PAN site. See [www.fountainbridgeci.org.uk](http://www.fountainbridgeci.org.uk).
- ◆ **Spokes is preparing ideas** to improve accesses and to reduce towpath congestion by improved conditions on adjacent roads

PANs normally have an exhibition and you comment to the developer – they should then take account of this feedback in their subsequent planning application.

### PAN CONSULTATION EXHIBITIONS

#### 14/00612/PAN 20 Mar Tollcross Comm Educ Centre 2-7pm

Exhibition of proposed changes to planned W.Tollcross residential development [was reference 11/03094/FUL]. Very important as could provide better (or worse) connection to the Canal-Meadows route, and connections to Lower Gilmore Place and Lochrin Place.

#### 14/00316/PAN 25 Mar Gilmerton Society Hall 10-7pm

Residential development bounded by Burdiehouse Road and Burdiehouse Burn. Site is greenfield and Green Belt.

#### 14/00309/PAN 27 Mar Central Hall, Tollcross 12-8pm. Also an unstaffed exhibition, 28/3-11/4, Fountainbridge Library.

Mixed use site bounded by Viewforth, canal, Fountainbridge, and east to Grove Street. Very important site: adjacent to the canal and basin, it could include a segregated path beside the towpath, avoiding the cobbles and a potentially congested towpath once the new school is open just along from here. It could also allow space for mandatory or segregated Fountainbridge cycle lanes. *Please go along and leave written comments, or email them in.*

#### 14/00885/PAN 3 May Ratho Community Centre, 10.30-17.30.

Residential Development, Ratho. 14-acre site on west side of Baird Road, bounded by old cement works to north.

## GLASGOW QS REBUILD

Glasgow Queen Street station is to undergo a massive rebuild to allow longer trains and to improve the George Square frontage. Plans are at an early stage and Network Rail is seeking comments from the public. After their failure to include a Bike Hub [with supervised storage, maintenance, etc] at Haymarket [although there will be improved bike parking] can Network Rail do better in Glasgow? ## TRAMLINE TRAUMAS

Tramline crashes are now less frequent than in 2013, with greater awareness by regular cyclists and with removal of the Haymarket taxi rank which forced cyclists into the tramlines. **Nonetheless they continue at a depressing rate** and we have had the first case where the victim was hit by a passing car, which ran over her foot. **The worst locations for crashes appear to be...**

- ◆ Cycling from Morrison St, past Haymarket, to Haymarket Ter
- ◆ Turning right from Lothian Road into Princes Street
- ◆ Travelling east in Princes Street at South St Andrew Street.

**It is vital to take every precaution and not believe you are immune. Many crashes are to experienced cyclists, some of whom use the same route every day and never expect to become a victim. Here are comments from recent victims:**

- ◆ [fractured cheek bone] *I am a very experienced cyclist and regularly commute 20 miles across Edinburgh*
- ◆ [stitches needed to chin] *Despite my awareness of accidents here and my best efforts to cross safely, I had a nasty accident*
- ◆ [bad grazing and bruising] *Experienced member of a cycle club.*

### WHAT HAPPENS NEXT ?

Now that the tramlines are being handed over to the council by the contractors, the council can make changes without the high penalty clauses which had applied to changes to the contract. The Council is looking at all locations where complaints have been received, and has allocated £50k for initial work in 2014/15. Some improvements are relatively easy and cheap; others would involve major changes to traffic and significant roadspace re-allocation.

At **Haymarket** small sums could improve current arrangements somewhat – for example, improved signing, lining and coloured surfacing for the 'semicircle' route recently marked just beyond the Haymarket 'jug-handle.' This could reduce crashes but certainly won't stop them all. Our longer-term solution [Spokes Bulletin 118] with a Morrison Street/ Haymarket Terrace segregated cycleroute would need roadspace re-allocation, consultation, traffic Orders, money and courage by the council. **If you support our idea, please ask your councillors to get it considered alongside the council's east-west cycleroute proposals.** [www.writetothem.com](http://www.writetothem.com)

## BIKE REPAIR STATIONS

Inspired by similar structures in North America and Australia, the **Edinburgh College Sustainability Department** has built four bike repair stations, hoping that having a set of tools and a pump at all campuses would encourage staff and students to cycle to work.

Built from recycled metal by the college's facilities team, at around £150 per unit, the structures include tools to change tyres or tubes, screwdrivers, spanners, etc. A pump is built in, ensuring it cannot be stolen. The stations have proved very popular and other institutions across the city now look set to follow the college.



**The repair stations are open 24/7 for anyone to use** - not just college members. Fortunately, 3 of the 4 campuses lie near busy cycle routes. **Granton campus** is connected to the Telford and Ferry road path and to Crumond promenade. **Sighthill campus** is near the new tramline path east to Murrayfield and an existing path west towards Edinburgh Business Park. The Innocent railway path connects the city centre to the college's **Milton road campus** near Portobello. Thousands of cyclists use these paths every day, and signs will point them to the repair stations. Two stations are near the main entrances of the **Milton road** and **Midlothian** buildings and the other two campuses get their stations shortly.

**CIVICRM** We are considering using this software to allow an online membership option. If anyone has experience using it and could offer comments/ useful advice please get in touch.

**DATA INPUT** Our databases currently use Microsoft Access. **We need another volunteer to help with data input.** You don't need to know Access as we have easy-to-use online input forms but **you need Access on your computer.** The system uses Access 2003 SP3 but more recent versions would hopefully be compatible.

Depending on time of year there is a batch of input every few weeks or every month or two, sharing the work with other helpers. Each is probably an hour or two's work and needs done ideally within a week or so. **Important: you need to be conscientious at boring data entry and more interested in accuracy than speed!**
