

## Picardy Place, Edinburgh



Henderson Global Investors (HGI) is hosting the first of two planned community consultation exhibitions regarding its proposals for land at Picardy Place, Edinburgh. The site is currently occupied by the Picardy Place traffic roundabout and surrounding road space. HGI's proposal is for the formation of a development site and erection of hotel with ground floor mixed uses and ancillary supporting infrastructure.

In 2009, City of Edinburgh Council approved Development Principles for Picardy Place which recognised the opportunity to fundamentally change Picardy Place and improve the important gateway to the city centre from a roundabout prioritising traffic movement to a high quality public place/development area.
