ELCRP is only the second CRP to be created in Scotland, following the success of several in England. The objective of a CRP is to encourage more locals and visitors to use rail, and it can identify improvements which are needed to help achieve this, though it cannot do active political lobbying.

#### **B3. NORTH BERWICK CYCLE GROUP - 'CYCLEFORTH'**

A new cycle campaign group has been created for North Berwick area., with objectives very similar to those of Spokes – to get better conditions for using a bike and to get more people cycling, especially for everyday journeys.

Amongst other ideas, Cycleforth is planning a survey of the new John Muir Way cycle route, which has been rather slapped into place without any real consideration of the cyclists who might use it – the group will be pressing for safety measures and tweaking of the route. Another aim is signed family-friendly cycle routes from the railway station to the two castles – little groundwork is required, just a commitment to get it done.

# C. MAINLY MIDLOTHIAN

#### C1. LOANHEAD – GILMERTON PATH NOW OPEN!! - photos wanted

The long-awaited Edinburgh disused railway section of this route is now complete and the council says it is receiving very positive feedback from users. The new path runs from the junction of Gilmerton Station Road/Lasswade Rd to an underpass of the city bypass, linking to Midlothian's existing path to Loanhead and Roslin.

*For the next Spokes Bulletin we'd like photos of this path* [in the next 2 or 3 weeks]. If you can supply any photos for possible use, please email them to DaveduFeuATgmail.com. Photos should not just show an empty path – they must include one or more people on bikes (with or without walkers too). Also, photos should not be all-helmeted; if there are several cyclists, at least half should be unhelmeted.

Edinburgh Council is hoping also in the next year to provide a better link further into the city from the Edinburgh end of the above new railway path.

#### C2. UPPER TWEED PATHS VOLUNTEER WORKCAMP - change of date - now starts 20 Sept

If you fancy helping build a cycleroute, led by Sustrans founder John Grimshaw, there is a workcamp to help convert an initial 4km section of the Peebles-Lyme disused railway. This will be a useful alternative to the main road, and another improvement to the Solway-Forth C2C route [for which a map was sent to all members in the summer mailing].

## D. MAINLY WEST LOTHIAN

#### D1. LINLITHGOW CANAL TOWPATH - please email

In addition to the previously-announced funding for links from the towpath to the Leisure Centre and Academy, Scottish Canals has now won an offer of £45m from Sustrans to extend towpath surfacing from the canal basin, past St Magdalene's, to the east end of the town. However, to receive this cash, Scottish Canals has to raise a matching £45m, and do the work by April 2015. They are hopeful of £35m from West Lothian Land Trust, but still need the remaining £10m.

If you'd like to see this project happen please email your councillors asking for their help in raising the final £10m, to get the towpath surfaced and to ensure that the Sustrans £45m offer is not lost. Find your councillors at www.writetothem.com.

#### D3. BATHGATE: STARLAW WEST - BOGHALL ROUNDABOUT 50MPH? - feedback by 3 Sept

West Lothian Council has won Sustrans funding for a cyclepath along the west verge between Starlaw West Roundabout and Boghall Roundabout, Bathgate.

To improve safety for cyclists and walkers who will use the cyclepath, council officers are considering reducing the speed limit between the two roundabouts to 50mph. This requires a Traffic Regulation Order and a decision by councillors. A report on the 50mph proposal is being prepared by officers for councillors and they are seeking comments.

#### D4. LIVINGSTON PATH NETWORK - WHEELING RAMPS - email your ideas to the council

West Lothian also has won funding to install wheeling ramps on the Livingston path network – presumably this is at steep access points which currently only have steps. The council would welcome comments from people who know the area, and suggestions as to which would be the most useful locations. ### D5. WLC LOCAL DEVELOPMENT PLAN, MAIN ISSUES REPORT [MIR] - Consultation, with September exhibitions

The Council is consulting on the MIR stage in producing its new Local Development Plan. This will be a hugely important document, governing how land is used in West Lothian, including many transport aspects and implications, such as planning development in such a way as to reduce the need to travel. Comments to the consultation from Spokes members would be really valuable.

The documentation is extensive, but short comments on one issue alone, such as cycling, are absolutely fine.

There will be a series of drop-in staffed exhibitions where you can also leave comments, all 10.00am-18.30pm.
