This circular is a little earlier than usual but there are some vital closing dates in 1 and 2 below.

## 1. BUS LANE CUTBACKS – OUR OBJECTION [please object & contact your councillors]

Awareness is growing over the Council plans to scrap Saturday bus lanes and cut the all-day weekday lanes to peak-hour only. Because this affects pedestrians as much as cyclists we have teamed up with Living Streets, who have now contributed to our draft formal objection. It will also be signed by Greener Leith community organisation, because the 'exemplary' Leith Walk will be compromised by the bus lane cuts; and by FOE (Scotland) who are concerned about pollution aspects.

We cannot understand why the council, whose policies are *succeeding* in raising cycling, bussing and walking, and cutting car use, should suddenly retreat, make cycling conditions more intimidating, pavements noisier and more splashy, and risking Edinburgh's hard-won reputation as a top public-transport city. Also another opportunity to point out that the planned pedestrian underpass of the A8 to the new Gogar tram/rail interchange (and onwards to the IBG) should allow cycling rather than get-off-and-push [a fight we lost, and probably now too late, but worth reiterating the point and use it to argue for top-quality surface access to the IBG].

# 3. DONALDSONS SCHOOL SITE EAST-WEST PATH ... Council Ref 15/00090/PAN [second exhibition, 19 March]

Many thanks to members who went to the Feb 3 PAN exhibition on this development, as notified in our last circular. The developers are now looking seriously at including this hugely valuable east-west path, which would provide an offroad connection between the Roseburn Path and the West End; from Wester Coates Gardens, through the site, to Magdala Cres.

## 6. SCOTTISH GOVERNMENT 2015/16 BUDGET - SUCCESS (SORT OF) !!

We have been campaigning hard since the draft budget was published in October. Our detailed investigations showed clearly that, as it stands, total cycling investment in 2015/16 would be down from 14/15, with infrastructure investment suffering particularly badly. This could affect future funding for council projects across Scotland – for example, Edinburgh's planned city centre Roseburn-Leith route. Many members contacted their MSPs – *thanks if you are one of them!* 

The final budget debate and vote were on 4 February, and the pressure worked, with **an extra £3.9m announced for cycling and walking infrastructure**. This brings total cycling expenditure in 15/16 up to equal its record 14/15 level. However, the total is still way below what would be needed to give a chance of meeting the government's 'vision' of 10% of trips to be by bike in 2020. Also the amount going to infrastructure still falls, as £5m was transferred from infra to 'Smarter Choices' at the time of the draft budget.

There is still a possibility of further cash, since there is a £20m 15/16 'Future Transport Fund' which is as yet unallocated. Last year the government provisionally announced that £5m of this would be for cycling infrastructure, and we have assumed that in our calculations. If it turns out to be more than £5m then total cycling investment in 15/16 will end up higher than 14/15, and we have some hope that this may happen.

## 7. SCHOOL STREETS CONSULTATION [consultation ends 27 Feb]

Edinburgh Council is to experiment with pedestrian/cycle-only zones outside 11 Primary Schools at opening and closing times – i.e. motor traffic will be banned at these times.

• **Bike Breakfast feeder rides organiser** Our annual bike breakfast is likely to be 17 June [date not yet confirmed]. Last year we really missed having someone to coordinate feeder rides from local areas, and so very few happened, unlike in previous years. A website is available to coordinate and publicise local rides, ride leaders etc, so we need a person to look after this and to be in touch with local ride leaders, list local politicians who are joining in, etc.

## 9. MAJOR CYCLEROUTE DIVERSIONS

#### a. DALKEITH/ESKBANK - BORDERS RAILWAY CONSTRUCTION

We have been sent the following info..

A diversion is in place around Hardengreen near Dalkeith. Hardengreen Lane will reopen fully, and as part of the National Cycle Network, at the end of May 2015. There may be access for pedestrians before that date. The work involved is the resurfacing of the lane and the construction of new footpaths leading to the new Eskbank railway station. There are also road works on Dalhousie Road, between Edinburgh College and Hardengreen Lane. This is the widening of the footpath to accommodate pedestrians and cyclists travelling to/from Eskbank railway station. The works will last some weeks and are funded by Midlothian Council and Sustrans.

### **b. A90 ROUTE TO FORTH BRIDGE**

The cycleroute is closed between Burnshot Wood and Barnougle Gate for approx 10 weeks from Feb 2<sup>nd</sup>, with a long (and hilly) diversion through Dalmeny Park – not good if you are commuting, but pleasant on an afternoon leisure ride! The new path beside the A90 will have 'vanes' to deal with the glare from car headlights, which is a particular problem here. [or 'veins' beside this 'arterial' road, as someone put it!]
