Spokes Action Update 26.02.15

1. MEMBERSHIP RENEWAL FOR 2015 - email renewal option

Our Spring mailout (with Bulletin 121) will be packaged up on Saturday and delivered from then on. *If you have joined or renewed since October you are already counted as a 2015 member*. Otherwise, you will find a renewal form in your mailout containing the details we currently have for you.

We are working on online joining and renewal, but this is not yet possible. You can renew (as usual) by returning the form to us, with any changes marked on it. However *if there are no changes to your details* you can, if you prefer, renew by email - your mailing will include a flyer explaining how to do this and how to donate by BACS or standing order if you prefer that to sending a cheque.

2. GLASGOW DELIVERY - volunteer needed

One of our members who lives in Glasgow delivers our envelopes there, but needs them taken to him in Glasgow. Is anyone travelling to Glasgow in the near future, and could collect his pile from Newington Road (Edinburgh) and take it to him at Woodlands Terrace (Glasgow) – it is quite central. If you can help please contact davedufeu AT gmail.com as soon as possible. Someone who could volunteer to do this regularly (3 times a year) would be especially valued!

3. GEORGE STREET FUTURE - please contact your councillors

As you may know, the George Street scheme is a 1-year experiment, operating under a Traffic Regulation Order which ends in September. Few people are aware that, unless the Council acts soon, George Street will revert to 2-way traffic (and no cycle lane) in September.

The Council intends to consult in the coming months on various options for the future (we are assured that all options will include segregated cycling of some form or other – possibly like now, or possibly one-way segregated on each side of George Street). However, by the time they have consulted, decided, created the legal orders needed, dealt with objections (using due legal process) and designed the new scheme in detail, it could easily be 12 months after September before anything is implemented.

In other words, we could have many months – perhaps over a year – of the old George Street traffic setup between September and the start of the new layout. Spokes feels this is a disaster. The Council should feel the same as its own surveys show that the public overwhelmingly prefer the current experimental setup to the previous two-way traffic. 72% of respondents found their visit to George St was now 'more enjoyable' and just 1% found it 'less enjoyable'!!

We are urging the Council to maintain the experimental layout until they are ready to install the new one. They say this would be difficult because of legal and practical issues with the Traffic Regulation Orders. We cannot believe that Edinburgh City Council cannot overcome these problems when there is still more than 6 months to run until the existing Order expires.

4. BUS LANE CUTBACKS - please contact your councillors

We are delighted at the level of support there has been for our campaign against the council's proposed cutbacks to bus lane timings. Whether or not we will succeed is unknown – it is a very difficult fight with the Council not wishing to be seen to change its mind – although we know for a fact that many officers in the Transport Department, and a good number of councillors, are worried about the proposal.

The date for formal objections has now passed. We know of many individuals who have formally objected – perhaps 30 or more, in addition to the detailed objections from ourselves, Living Streets (the pedestrians' association) and others. However, it is now really valuable to email your councillors as a report on the objections will be going to the Transport Committee in a few weeks time, at which time a final decision will be taken on whether or not to scrap the scheme.

If you support us and have not yet contacted your councillors, please do so !!

We cannot understand why the council, whose policies are *succeeding* in raising cycling, bussing and walking, and cutting car use, should suddenly retreat, make cycling conditions more intimidating, pavements noisier and more splashy, and risking Edinburgh's hard-won reputation as a top public-transport city.
