3. EAST-WEST CITY-CENTRE CYCLEROUTE CONSULTATION - responses are vital

We stress the importance of individuals (like you!) responding to this Council consultation – undoubtedly the most important ever by Edinburgh on a cycling project, providing a largely segregated route from Roseburn through the city centre via George Street, and continuing to the segregated lanes promised on Leith Walk and Picardy Place. The project will take significant amounts of space from parked and moving motor traffic, and as such there is likely to be significant opposition to the plans, so support is vital.

In our cycling 'bubble,' where cycling has so many positives, it can be difficult to imagine how opposition can build up – often from taxi firms and/or shopkeepers. But in parts of London, posters have appeared and public meetings been held calling for plans to be scrapped; for example see this recent Guardian article... www.theguardian.com/cities/2015/oct/05/bike-lane-blues-london-local-businesses-cycle-enfield-green-lanes

We very much hope things will not reach that stage in Edinburgh, but it emphasises the need for maximum support for the proposals from large numbers of individuals, as well of course as the main Spokes response. Some councillors are nervous about the likely level of opposition, and so maximum support is vital.

Of course, you may well have comments on how the plans could be improved – if so, please do make your suggestions – that is what the consultation is for! - but please do so in a positive context, saying how pleased you are to see the Council coming forward with an ambitious scheme like this [assuming you are!] and then pointing out how you would like it improved further.

4. NORTH-SOUTH ROSEBURN-CANAL CYCLEROUTE CONSULTATION - please respond

The Council has surprised us with another major consultation – a year or so earlier than we were expecting it! This is for a very ambitious connection from the North Edinburgh Network to the Canal. This time the ambition is in how much it is likely to cost, due to several new bridges.

There is likely to be much less opposition than for (3) above, since this mainly doesn't use road space. **However, it is still important to respond**, to say how useful this will be and to suggest any improvements. We aren't sure where the money will come from – it would almost certainly be too costly for the Council's cycle budget. However there are some other possible sources, including a City Region bid which could bring Edinburgh and the nearby Councils a huge sum for infrastructure investment of many kinds. If this cycleroute project is seen as being valuable to many people, that increases the chances of getting cash from such sources.

5. PLANNING APPLICATIONS to comment/object & PAN EXHIBITIONS to attend

Check our page of cycling-relevant planning proposals every week or two to see if any affect areas where you live, work or otherwise cycle. As explained there, a PAN is the stage before a Planning Application. It involves a public exhibition and consultation on a major development before the developer is allowed to submit their planning application.

6. EDINBURGH - AN ATTRACTIVE CITY TO WORK IN - send us any useful information

Unlike most UK and Scottish cities, Edinburgh has no inner city motorways. Its city-centre industries are moving from those requiring heavy transport, and with relatively few staff, to those working electronically and with many more staff for a given area.

For example, the former Brewery in Holyrood Road, became the Scotsman offices (with less machinery and with more staff) and that building in turn becomes home to Rockstar North, an international video games developer needing only computing equipment, and with 1800 Edinburgh staff. The company uses its central Edinburgh location as an attraction to potential new high calibre employees.

We'd be interested to hear of other companies for whom being based in an increasingly attractive, walk/cycle-friendly environment is seen as important in attracting staff. Information like this can be useful in helping persuade councillors to be bolder with new cycling, walking and traffic-free or traffic-reduced development, and put investment in that direction. Please email Spokes if you can add to the evidence.
