SUPER(?)MARKETS

The Spokes supermarkets bike parking and access project has begun, starting with an online survey to assess the current position in Edinburgh/Lothian. Outcomes from the project could include...

- ◆ A report on supermarket bike parking/access in Edinburgh/Lothian
- ◆ Materials to help shops encourage customers to come by bike including local stores as well as supermarkets
- ◆ Materials to help individuals like you to tackle local store management
- ◆ Lobbying the council to ensure that every new store (including onstreet 'Express' supermarkets) has decent bike parking and access
- An attempt to engage with supermarket Regional Managers to ensure all their stores meet a high standard.

BUS LANES

The Council has received a considerable number of objections from individuals to the Traffic Orders which will allow it to convert full-time bus lanes to peak-hour only, and to scrap Saturday bus lanes altogether. We cannot understand why the council is doing this and, indeed, it directly contradicts their own official transport policy document, the <u>Local Transport Strategy</u>.

A report on the objections goes to the Transport Committee on 2nd June. However, councillors will be making up their minds before that, so **if you have not contacted your councillors yet, please do so now**. Ask them to think carefully about what they are proposing to do, and why, and to scrap this 18-month experiment.

KILGRASTON ROAD

The Council has published the results of its consultation into onroad improvements from Marchmont Road to Kings Buildings. Of the 301 responses, 69% supported the plan overall, with 20% opposed. There were also many detailed comments.

We have also had a response to the Spokes submission. Many of our detailed suggestions (including reduced car parking in places) have been provisionally agreed subject to further investigation, after which detailed plans will hopefully be available.

However we are very disappointed that there is no real change to the plans for Kilgraston Road – which is probably the most unpleasant part of the route, being fairly narrow, steep and with significant traffic. We had suggested closing the road to all but pedestrians, bikes and buses or, if that was not agreed, a mandatory uphill cycle lane and no parking on the downhill side. Instead, only an advisory uphill lane is proposed.

GEORGE STREET

The George Street experiment ends in September, and unless the Council acts soon there will be no cycle facility until a new scheme is in place — which could be a year or more. Ask your councillors for good cycling conditions in this interim period.

GOVT FUNDING

We are expecting an announcement any time soon as to how the Scottish Government will use its 15/16 cycle cash – i.e. how much will go to Sustrans, to Cycling Scotland, and to any other projects. Going on past experience it will sound as if this is new money, whereas it may just be saying how existing cash will be used.

The total is however still uncertain, since, for example, there is an approved £20m Future Transport Fund, some of which will go to active travel, but how much is not yet known. There is also cash from various other 'lines' in the budget, and the new Transport Minister Derek Mackay has said he is very supportive of cycling.

In total, however, we expect cycling investment to be no more than 2% of total government transport spending – unlike Edinburgh who are investing 8% of their transport budget. As usual we will attempt to distil the reality from the spin!

- Roslin-Shawfair cycleway. Roslin-Loanhead section extended to Lasswade Road. Intention is for Edinburgh Council to extend to Gilmerton Road and ultimately Shawfair.
- ◆ Roslin to Peebles plan to use old railway line in part discussions ongoing with Borders and Midlothian Councils.
- Access through Dalkeith Palace. Generally through cycle access unrestricted but Group Runs please advise Estate Office in advance.
- Road Safety. A701 Milton Bridge Removal of Traffic Islands & installation of cycle lanes
- Road Safety. A68 northbound at turnoff for A6106 to Dalkeith cycle lane pending and signage to Edinburgh & Musselburgh to discourage use of A68 Bypass by cyclists

EAST LOTHIAN NEWS

NORTH BERWICK 'CYCLEFORTH' CAMPAIGN

Cycleforth is a local campaign for improvements for cyclists, focussing especially on safety and provision of facilities, and with several Spokes members among them. Below are some of their achievements in just one year. Website & info: cycleforth.org.uk.

- Surveyed the John Muir Cycle Way from the centre of North Berwick west to Dirleton. Produced a detailed report and recommendations.
- Lobbied East Lothian Council to apply for Sustrans Community Links funding for building a safe cycle route between North Berwick and Gullane. Success: an application was made in February and regardless of its outcome, ELC have promised to upgrade the first section from Strathearn Road to the garage. Work started at the beginning of March.
- Suggested cycle parking locations in North Berwick and Gullane. New Commonwealth Games racks have been installed at three sites in NB (have you found them yet?) and we await others promised by April in town and village centres to help shoppers arriving by bike.
- Attended East Lothian Cycle Forum and raised local issues.
 Attended Spokes Public Meeting on cycle provision in Lothian.

Inspired by CycleForth?? Why not do similar in your own town or district. We can put you in touch with other local members.

PLANNING APPS / PANS

Remember to check our web page of Planning Applications or PANs relevant to cycling [PANs are a public consultation for big developments, prior to a Planning Application] — possibly a potential cycle access or connection, bike storage needed for residents, bike parking for visitors, etc. The page also explains how to look up PAs/PANs on the council website and find details of exhibitions, etc. You comment on *planning applications* direct to the council. For *PANs* there is an exhibition and you comment to the developer who should then take this into account in their subsequent PA.
