# **EAST-WEST ROUTE**

Public consultation on the city centre east-west route, Roseburn to George Street to Leith Walk is expected to begin Monday 16<sup>th</sup>. A Council report to the Oct 27 Transport Cttee explains the proposal. We urge everyone interested to make a personal response don't just leave it to Spokes and others. We'd like to see your thoughts too, for possible inclusion in the Spokes response.

There will undoubtedly be changes we'd like to see but it's vital to realise what a major step this is for the politicians: a segregated route to and through the city centre taking significant roadspace from moving and parked traffic. It's a whole new step in political courage by councillors, and should significantly boost bike use.

It is likely there will be major opposition to the scheme – maybe from taxi companies, maybe shop frontagers, maybe others. This is happening now in London in some of the 'Mini-Holland' proposals, with huge posters and public meetings called to oppose the plans. Cycle campaigners who initially were arguing for much more have had to turn instead to organised defence of the Council.

Hopefully things will not reach that stage in Edinburgh, but it emphasises how vital it is actively to support the proposals. Of course, it's important to point out where the plans should be improved, but please do this in a positive context, starting by complimenting the Council on coming forward with the plan.

Remember too that this is a *consultation*, not a final plan. It can be improved – but equally it risks being cut back in the face of opposition. Sections particularly at risk could be the segregated route at the east end of Princes Street [which we are delighted to see in the plans!] and the shopfront section at Haymarket Terrace.

### MEADOWS-CANAL needs YOU

Edinburgh Council has received much praise over its recently opened Innocent-Southside-Meadows route, with main road lightcontrolled crossings and segregated onroad sections. It had been widely expected that the similar-design Meadows-Tollcross-Canal continuation would follow by 2016 – see original timescale below [NB the photos show the existing routes, not the proposed!!]

# **500,000 BIKE TRIPS!!**

Following the Scottish Household Survey report that 11.8% of Edinburgh commuter trips are by bike [Spokes Bulletin 123] the Middle Meadow Walk Bike Counter on November 13 registered the 500,000<sup>th</sup> bike trip of 2015. #### The Road Share Campaign for Presumed Liability

The campaign aims to protect vulnerable road users, e.g. cyclists and pedestrians. The UK is out of step with Europe, being one of only five EU countries (along with Cyprus, Malta, Romania and Ireland) without some form of strict liability regime for vulnerable road users. Strict liability is already established in other areas of UK law, such as for employers and those in charge of dogs.

As a consequence, our current system expects those injured, or the families of those killed, to go through an often protracted and harsh process to gain treatment, care or compensation. In Europe, strict liability regimes are seen as an integral factor of cycle safety.

The Scottish Government has a policy to encourage walking and cycling so surely it should offer them this legal protection? - it has the power to introduce this principle into civil law. By introducing presumed liability, the Scottish Government has the opportunity to lead the UK in the welfare and status of cyclists and pedestrians.

#### Sign our petition to support Presumed Liability

To help change the culture on our roads and ensure that vulnerable road users are treated correctly in the event of a road traffic collision, please sign the Road Share online petition calling for a Bill to introduce Presumed Liability between motorists, cyclists and pedestrians. If you have already signed, thank you – and could you now ask a friend or relative to sign too? Please also share your views with your MSPs – they need to be convinced.

## **UTILITY CO. DANGERS**

From Spokes Planning Group...

Road conditions that make cycling dangerous cause anxiety, are off-putting and give rise to accidents. Spokes encourages cyclists to report any dangerous road conditions such as potholes, sunken drains or loose or smooth manhole covers. Councils are ultimately responsible for ensuring safe road conditions but water, gas, electricity and telecommunications companies are each responsible for maintaining their own infrastructure including manhole covers.

Edinburgh City Council has been working for a number of years to push utility companies to adopt better maintenance standards but these efforts have so far not been sufficiently effective. Spokes is considering how we can best put pressure on utility companies to improve their standards and, in doing this, details of other cases of unacceptable responses will be very helpful.

One member has been in touch to highlight some very poor Scottish Water performance in responding to two reported clear dangers for cyclists - smooth manhole covers, which provide no grip in wet conditions, on downhill stretches where sharp turns are necessary. Although the need for replacement is not disputed, they have taken no action since the two problems were reported in writing five and nine months ago – and despite several reminders.

Spokes wants to hear if other members have evidence of similar appalling response standards by Scottish Water or any other utility company. If so please email details to *planning AT spokes.org.uk*.

# **FAULT REPORTING**

Co-incidentally, Spokes member Ross Hendry from West Lothian has emailed us about fault reporting. His comments were about West Lothian, but most are applicable in other Councils, so we have expanded them to include that.

As well as potholes and other road problems, Ross points out that anyone who cycles on the path network in West Lothian will be aware of the problem of broken glass, often regularly in the same locations, underpasses, secluded seated areas, etc.

In reporting a problem it is vital that the Council can locate it easily, without wasting time. One good method for urban street problems is to give the *number on the nearest lamp-post*. It should be 2 letters and 2 numbers in a square. Some reporting systems, such as FixMyStreet (below) let you use a marker pin on a map.

Unfortunately each Council has its own reporting method. Simplest therefore is to use one of the generic reporting sites which pass on reports of potholes, broken glass, faulty street lights, etc to the relevant section of the relevant council. For example, <a href="https://www.fixmystreet.com">www.fixmystreet.com</a>, which also includes apps for reporting and which is operated by the Social Enterprise <a href="https://www.mysociety.org">www.mysociety.org</a>. Ross reports that this has worked well for him.

If you prefer to use a Council website look there for a heading called *Report It*, then follow the links. If you can't see that, typing *pothole* in the search box nearly always gets you the right page.

Below we list council websites, also with numbers for phone reporting. And if you are reading this Spokesworker electronically, clicking the website name should get you to the reporting page.
