EDINB PARK by 25

Massive planning applications have been lodged for the huge last remaining vacant area in Edinbugh Park - straddling the tramline between Lochside Way and the rail station.

The plans include a dual carriageway (a 'boulevard') and two multi-storey car parks (plus residential parking) - despite a tram down the middle, an adjacent rail station and being in the heart of the Council's planned West Edinburgh mini-Holland project, for which it has won significant Community Links Plus funding [see 'Big Projects' article]. Shades of the Picardy Place scenario!!

The plans in their present form would be a serious blow to the Council's ambition to reduce car dependency and promote health.

More generally, for such a massive development there should be a public exhibition and consultation before the detailed application.

WHAT YOU CAN DO

- ◆ Object to the Planning Applications, as follows...

 - →Say you are objecting to planning applications 17/04341/AMČ, 17/04349/AMC & 17/04391/FUL - all for 'Edinburgh Park (South)'
 - **→Then** give your reasons.

LEZs by 28 I

The Scotland Programme for Government [Spokes 129] revealed that Low Emission Zones (LEZs) will be established in Edinburgh, Glasgow, Aberdeen and Dundee by 2020. The government is now consulting on how to design, build and manage LEZs.

WHAT YOU CAN DO

- If you want a simpler and quicker way of responding, use the Friends of the Earth consultation tool at <u>act.foe.scot/support-lezs</u>.
- There is a danger of some Councils concentrating only on buses initially - there has already been some talk of that in Glasgow. We suggest focusing equally or more on tackling private vehicles and ensuring that active travel and public transport are part of the solution to LEZs – as well as to many other urban problems.

BIG PROTECTS

As mentioned in Spokes 129, Edinburgh Council has won £m's from the Sustrans Community Links Plus competition, for Meadows-George Street and West Edinburgh 'mini-Holland' projects. These are at a conceptual stage, with initial options still to be defined but we understand that outline details will appear shortly on the council website. With a bit of luck you'll be able to find them by searching for Cycling Projects at edinburgh.gov.uk.

LEITH STREET by Oct 31

Although work is underway in Leith Street, the Redetermination Order covering its use is only now out for objections & comments. This type of Order (an RSO) is powerful, as if there are unwithdrawn objections then there has to be a government inquiry. So if you are unhappy with the proposals, do object!!

Living Streets has already submitted an objection, and Spokes will be doing so. Individual objections will help back this up.

The Order is RSO/17/13. To find it, go to...

ISSUES WHICH CONCERN SPOKES

- ◆ The maps accompanying the Order show the areas of footway, cycleroute and carriageway affected but are not **detailed plans** e.g. details at junctions. This makes comment more difficult than it should be. We have been asking for these plans.
- ◆ The Order should allocate more space to walking and cycling, and only provide carriageway space for buses, taxis and emergency and service vehicles the present Leith Street closure shows that traffic patterns can adjust. It should also include segregated cycle provision right to the top of Leith Street, instead of just to Calton Road as in the draft Order.
- ◆ If the above is not agreed at this time, then at the very least an **uphill advisory cycle lane** should be included, from the end of the segregated route (at Calton Road), up to the top of Leith Street, ending in a deep advanced stop area where the road narrows immediately before the junction at Waterloo Place.
- ◆ There appears to be no consideration for how cyclists heading for the top of Leith Street will leave the segregated cycleway which ends at Calton Road although we expect many more to be heading up Leith Street than heading for Calton Road.
- ◆ The **junction arrangements** at Calton Road and Greenside Row are unclear but, as far as we can see, they look unsatisfactory for both cyclists and pedestrians.

WHAT YOU CAN DO

- ◆ Object to the Order, as above. See the points above which concern Spokes. Even if you don't have time to look at the full Order, object to any main points that concern you.

PICARDY PLACE soon

A huge amount has happened in recent weeks, following the news that Picardy Place was to be rebuilt imminently as a gyratory, with virtually zero public consultation - and the resulting furore and Transport Committee motion by Cllr Chas Booth. Some of the background is on our website [August 11 article] and more recent developments have been well covered by the local community newspaper broughtonspurtle.org.uk [articles Oct 2,5,10 & more].

The present situation is that some form of public consultation is expected in October and a final decision will be made by the Transport Committee on 7 December. We hope the consultation will take account of recent comments by Spokes and others.

The problems are due partly to a Council decision some years ago to allow 1800 car spaces at St James, up from 550 - so bigger roads are 'needed.' For that, and for subsequent financial and legal reasons, the gyratory now seems 99% certain – but the Council has said that cycle and pedestrian aspects can be modified extensively.

ISSUES WHICH CONCERN SPOKES

- We **oppose the gyratory**. But assuming it does go ahead, our main thoughts at this stage are as below. We also note that, though the current plan is disappointing overall, and the cycling provision needs improvement, it is better than the present roundabout!
- ◆ The final design must be **such that it can be modified in future** to a traffic-reduced more pedestrian-friendly design. In particular, the huge triangle inside the gyratory should not be built on it should be open space to allow maximum future scope for a T-junction instead of gyratory when less traffic is deemed possible.
- ◆ The planned 'shared space' in front of the cathedral and elsewhere should be changed to segregated cycle and pedestrian
- ◆ The **main road crossings** should be side-by-side ('tiger') cycle/pedestrian crossings, not combined 'toucan' crossings.
- ◆ There should be **clear and direct cycleroutes** for all important directions, including...
- o The west-east route, York Place ↔ Leith Walk
- ∘ Broughton Street ↔ Leith Street
- Leith Walk ↔ Waterloo Place
- ◆ Cycleroutes must be **laid by machine**, not hand-rolled, which caused the bumpy Causewayside & Pleasance cycleroutes.
- ♦ We do not know if this consultation will include **Leith Street**. If so, there are additional vital issues see separate article and they need included here too if this consultation also covers it.

WHAT YOU CAN DO

- Keep your eyes open for the consultation, and go along to the exhibition and/or respond online.
- Consider our points above when making your response.

SETTED STREETS

Edinburgh has recently consulted on the future of setted streets. This follows our successful initiative early in 2017 [Spokes 127 p6] to get a Committee Report postponed as it virtually ignored the implications of certain types of setts for cyclists or pedestrians.

The consultation is now complete, but officers are preparing a report due to go to the 7 December Transport Committee. *If you have views on setted streets and/or would like to support our paper* it's worth contacting your councillors and asking them for your views to be taken into account in the report.

TRAMLINE SAFETY

The Council has been installing Phase 1 of its measures to try and ameliorate the dangers resulting from the tramline layout.

Predictably, nearly all the resulting comment has been on the pros and cons of the red surfacing (and there are both pros and cons) but it is important to remember that much of the campaign is aimed at making motorists more aware of the presence of bikes and to give bikes space around the tramlines. Motorists are reminded by signs, bus-back adverts, and the red surfacing.

Subsequent phases take longer because they need Traffic Orders, wider consultation with operators, etc, and will involve changes to ASLs, traffic lights, some changes to road layouts, etc.

Of course this is only ameliorating a layout which could have been a lot more bike-friendly from the outset if it had been designed more holistically, as we unsuccessfully campaigned for.
