THE CITY OF EDINBURGH COUNCIL (BUCCLEUCH STREET, CHAPEL STREET, EAST CROSSCAUSEWAY, NICOLSON STREET AND, WEST CROSSCAUSEWAY, EDINBURGH) (REDETERMINATION OF MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE) ORDER 201_ RSO/16/12

The City of Edinburgh Council, in exercise of the powers conferred on them by section 1(1) and 152 (2) of the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf, hereby make the following Order:-

- This Order may be cited as "The City of Edinburgh Council (Buccleuch Street, Chapel Street, East Crosscauseway, Nicolson Street and, West Crosscauseway, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 201" and shall come into operation on the _ day of Two thousand and _.
- 2. The roads in the City of Edinburgh local government area specified in the First Schedule to this Order, at present carriageway, shall become footway, the right of passage being exercisable on foot only.
- 3. The roads in the City of Edinburgh local government area specified in the Second Schedule to this Order, at present carriageway, shall become cycletrack, the right of passage being exercisable by pedal cycle and foot only.
- 4. The roads in the City of Edinburgh local government area specified in the Third Schedule to this Order, at present footway, shall become cycletrack, the right of passage being exercisable by pedal cycle and foot only.

SCHEDULE 1

ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM CARRIAGEWAY TO FOOTWAY

Chapel Street

North-east side

All that part of the carriageway on the north-east side of Chapel Street from the intersection of the south-east kerbline of West Nicolson Street and the north-east kerbline of Chapel Street, south-eastwards;

- a) for a distance of 2 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby, and then
- b) for a distance of 46 metres or thereby and which has a width that varies from 2 metres or thereby to 1 metre or thereby.

(marked 1 on the attached plan).

All that part of the carriageway on the north-east side of Chapel Street from a point 51.5 metres or thereby south-east of the intersection of the south-east kerbline of West Nicolson Street and the north-east kerbline of Chapel Street, south-eastwards;

- a) for a distance of 3.5 metres or thereby and which has a width that varies from 1 metre or thereby to 3 metres or thereby, then
- b) for a distance of 12.5 metres or thereby and which has a width throughout of 3 metres or thereby, and then
- c) for a distance of 9.5 metres or thereby and which has a width that varies from 3 metres or thereby to 2 metres or thereby.

(marked 4A on the attached plan).

See Buccleuch Street, East side. (marked 7 on the attached plan)

South-west side

All that part of the carriageway on the south-west side of Chapel Street from the intersection of the south-east kerbline of Windmill Street and the south-west kerbline of Chapel Street, south-eastwards;

- a) for a distance of 2 metres or thereby and which has a width that varies from 0 metres or thereby to 1.5 metres or thereby, then
- b) for a distance of 84 metres or thereby and which has a width throughout of 2 metres or thereby, then southwards into Buccleuch Street
- c) for a distance of 10 metres or thereby and which has a width that varies from 2 metres or thereby to 2.5 metres or thereby, then
- d) for a distance of 37.5 metres or thereby and which has a width throughout of 2.5 metres or thereby, and then
- e) for a distance of 5 metres or thereby and which has a width that varies from 2.5 metres or thereby to 0 metres or thereby.

(marked 2 on the attached plan).

Buccleuch Street

East side

All that part of the carriageway on the east side of Buccleuch Street from a point 4 metres or thereby south of the intersection of the north kerbline of Buccleuch Place and the east kerbline of Buccleuch Street, northwards;

- a) for a distance of 53 metres or thereby and which has a width that varies from 0 metres or thereby to 1.5 metres or thereby, then north-westwards into Chapel Street
- b) for a distance of 53 metres or thereby and which has a width that varies from 1.5 metres or thereby to 3 metres or thereby, and then
- c) for a distance of 10 metres or thereby and which has a width throughout of 3 metres or thereby.

(marked 7 on the attached plan).

West side

See Chapel Street, West side. (marked 2 on the attached plan)

West Crosscauseway

North side

All that part of the carriageway on the north side of West Crosscauseway from the intersection of the west kerbline of Nicolson Street and the north kerbline of West Crosscauseway, westwards;

- a) for a distance of 2 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby, and then
- b) for a distance of 9 metres or thereby and which has a width throughout of 2 metres or thereby.

(marked 10 on the attached plan).

East Crosscauseway

North side

All that part of the carriageway on the north side of East Crosscauseway from the intersection of the east kerbline of Nicolson Street north kerbline and the north kerbline of East Crosscauseway, eastwards for a distance of 4.5 metres or thereby and which has a width that varies from 4.5 metres or thereby to 1 metres or thereby. (marked 11 on the attached plan).

South side

All that part of the carriageway on the south side of East Crosscauseway from the intersection of the east kerbline of Nicolson Street north kerbline and the south kerbline of East Crosscauseway, eastwards for a distance of 0.5 metres or thereby and which has a width that varies from 0.5 metres or thereby to 0 metres or thereby. (marked 12 on the attached plan).

SCHEDULE 2

ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM CARRIAGEWAY TO CYCLE TRACK

Chapel Street

North-west side

All that part of the carriageway on the north-east side of Chapel Street from a point 48 metres or thereby south-east of the intersection of the south-east kerbline of West Nicolson Street and the north-east kerbline of Chapel Street, south-eastwards for a distance of 3.5 metres or thereby and which has a width throughout of 1 metre or thereby. (marked 3 on the attached plan).

All that part of the carriageway on the north-east side of Chapel Street from a point 77 metres or thereby south-east of the intersection of the south-east kerbline of West Nicolson Street and the north-east kerbline of Chapel Street, south-eastwards;

- a) for a distance of 1.5 metres or thereby and which has a width that varies from 2 metres or thereby to 3 metres or thereby, and then
- b) for a distance of 2 metres or thereby and which has a width throughout of 3 metres or thereby.

(marked 6 on the attached plan).

West Crosscauseway

South side

All that part of the carriageway on the south side of West Crosscauseway from the intersection of the rear of west footway of Nicolson Street and the south kerbline of West Crosscauseway, westwards;

- a) for a distance of 0.5 metres or thereby and which has a width that varies from 0 metres or thereby to 2.5 metres or thereby, then
- b) for a distance of 4 metres or thereby and which has a width throughout of 2.5 metres or thereby, then
- c) for a distance of 2.5 metres or thereby and which has a width that varies from 2.5 metres or thereby to 0 metres or thereby, and then
- d) for a distance of 8 metres or thereby and which has a width that varies from 0 metres or thereby to 1 metre or thereby.

(marked 8 on the attached plan).

East Crosscauseway

South side

All that part of the carriageway on the south side of East Crosscauseway from the intersection of the west kerbline of Nicolson Street and the south kerbline of East Crosscauseway, eastwards;

- a) for a distance of 4.5 metres or thereby and which has a width that varies from 3 metres or thereby to 1.5 metres or thereby, and then
- b) for a distance of 10 metres or thereby and which has a width throughout of 3 metres or thereby.

(marked 14 on the attached plan).

SCHEDULE 3

ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM FOOTWAY TO CYCLE TRACK

Chapel Street

North-west side

All that part of the footway on the north-east side of Chapel Street from a point 48 metres or thereby south-east of the intersection of the south-east kerbline of West Nicolson Street and the north-east kerbline of Chapel Street, south-eastwards for a distance of 3.5 metres or thereby and which has a width throughout of 2 metres. (marked 4 on the attached plan).

All that part of the footway on the north-east side of Chapel Street from a point 77 metres or thereby south-east of the intersection of the south-east kerbline of West Nicolson Street

and the rear of the north-east kerbline of Chapel Street, south-eastwards for a distance of 1.5 metres or thereby and which has a width that varies from 1 metre or thereby to 0 metres or thereby.

(marked 5 on the attached plan).

Nicolson Street

West side

All that part of the footway on the west side of Nicolson Street from the intersection of the south kerbline of West Crosscauseway and the rear of the west footway of Nicolson Street, northwards for a distance of 2.5 metres or thereby and which has a width that varies from 2 metres or thereby to 0 metres or thereby. (marked 9 on the attached plan).

East side

All that part of the footway on the east side of Nicolson Street from the intersection of the south kerbline of East Crosscauseway and the rear of the east footway of Nicolson Street, northwards for a distance of 1 metre or thereby and which has a width that varies from 4 metres or thereby to 0 metres or thereby.

(marked 13 on the attached plan).

All as the lengths of roads are shown in saw-tooth hatching on the plan annexed and executed as relative to the Order.
