#### **BACKGROUND & SUMMARY OF PROPOSALS**

See the May 11 article on our website, 'Yes, it's a Transformation.' See also the <u>Summer Spokes Bulletin #134</u> and its supplement.

#### POINTS TO CONSIDER

However if you have time to raise specific issues, think about the points below. These are all being considered for our official Spokes response – and can be discussed at our public meeting.

- ♦ Overall we are delighted, but...
- ◆ **Timescale** although some projects start soonish, 10 years is a long time for the complete Transformation programme.
- ◆ Car-free streets is the proposed area extensive enough?
- ◆ Wider policies will the Transformation be undermined by ever more car use outside the city centre, e.g. allowing more cardependent housing. Will the *Mobility Plan*, which will cover the whole city, be tough enough to restrict motor traffic volumes and provide quality cycling conditions on arterial and suburban roads?
- ◆ Morrison Street the overall map suggests a segregated cycleroute, but the more detailed cycle map does not and the artist's impression of Morrison Street does not.
- ◆ Leith Street both maps suggest a segregated cycleroute connecting the Bridges corridor to Leith Walk but the Council had previously ruled that out because of the very tight junction at the top of Leith Street. How will the route be implemented?
- ◆ **Princes Street** it is very unclear what is intended in this vital street as regards cycling, both in the short term and medium term. For many trips, George Street is not a suitable alternative.
- ◆ North Bridge to George Street no cycle connection is shown.
- ◆ West End Junction this is shown as a 'priority' ... will that really mean *early action?* It is where Zhi Min Soh was killed and has continuing injuries due to the combination of heavy traffic and tramlines. A bike crossing from Lothian Road and Rutland Square to Charlotte Square and Queensferry Road is also long overdue.
- ◆ Pedestrian areas 'shared space' should be avoided wherever possible, and a cycling 'mini-carriageway' included, perhaps as in the Meadows-George St proposals for Forrest Road.

#### POINTS TO CONSIDER

Even a quick response, giving overall support, is very valuable, as there will be objections from people who don't like the plan. However if you have time to raise specific issues, some points to consider are below. Please tell us if we've missed anything!

- ◆ Overall we are delighted, but...
- ◆ Timescale construction is not planned until 2022 (and it is not clear whether even that timescale allows for any objections which have to go to a government Inquiry, as is currently holding up phase 1 of the West-East route for about a year).
- ◆ Type of cycleroute a bidirectional (i.e. 2-way) cycleroute is planned rather than unidirectional on each side of the road. There are arguments for and against. Generally we prefer unidirectional, but we have not yet decided in this particular project.
- ◆ Cycleroute width the planned 3m is less than the 4m proposed for George Street. Spokes traffic counts show many cyclists in the rush hour, and the flow is not entirely in one direction. A width of 4m is also much better for different types and ages of cyclists using the same route together, and for cargo bikes, trailers, etc.
- ◆ Junctions the design must enable cyclists to turn in and out of other streets safely, particularly if the route is bidirectional. This includes Chambers St, Candlemaker Row, Market St, Hanover St, and the existing semi-invisible left turn at foot of the Mound.
- ◆ **Teviot Row** a link to the university area should be included.

## SAFER STREETS AT RISK

The Bill for a default 20mph limit in urban areas in Scotland, to replace the present 30mph default, after 2 years work by Mark Ruskell MSP, is at serious risk. A parliamentary debate and vote is expected on June 13, and indications are that the SNP government, assisted by the Conservatives and possibly the Lib Dems, are likely to vote against, and thus scrap the Bill entirely.

#### Mark Ruskell MSP writes...

"The Safer Streets Bill makes one simple change. It switches the default speed limit in urban areas from 30mph to 20mph. Here's ten reasons why we should do it...

- 1. ScotGov's target is for of 10% of journeys to be by walking and cycling by 2020, but we're currently at 1%
- 2. Wales has already committed to make the switch, and London is rolling twenty out too.
- 3. Bristol Council estimate their 20mph roll out saved 4 lives a year. Imagine if we rolled that out across the whole of Scotland.
- 4. Twenty has its biggest impact in deprived communities, where children are 3 times more likely to be killed or injured by cars.
- 5. When Fife Council rolled out twenty, casualties fell by 34% in poorer communities (20% in more affluent neighbourhoods).
- 6. An average of 7 children are killed a year on roads in Scotland.
- 7. Every 1 mph reduction in average speed reduces road traffic accidents by 4-6%.
- 8. In Edinburgh, where twenty has been rolled out, average speeds have fallen and support grown to 80%
- 9. 20mph limits have been shown to increase cycling by up to 12%
- 10. The Royal College of Paediatrics and Childhood Health believe this bill is essential in encouraging children and young people to feel safe to cycle, walk and play outdoors.

The Safer Streets Bill is backed by dozens of civil society bodies and opposed only by the motoring lobby. However, at the end of May a Committee of MSPs published a (non-unanimous) report stating that the Bill takes a "blanket approach" and would cost too much to implement (not counting the value of lives and injuries saved). The Twenty's Plenty campaign called the report "Illogical, innumerate and deeply flawed" and accused the Committee of "a shocking disregard for protecting lives".

Sadly, the report reflects a caving in of the SNP, LibDem and Tory MSPs on the Committee to the motoring industry. Unusually, however, three Committee members refused to back the report -John Finnie (Greens), Colin Smyth (Lab) and John Mason (SNP).

Despite this report, Parliament is perfectly capable of passing the Bill – but the critical factor will be whether the SNP government asks its MSPs to vote for or against. Every MSP matters, so please contact yours urgently if you have not yet done so.
