# 0. Finding your councillors

Find your councillors by typing your postcode on <u>this page</u>. If you already know your ward, <u>go here</u>. Note that everyone has either 3 or 4 councillors, usually from assorted parties.

# 1. Future of Spaces for People (SfP) – major Edinburgh Council decision soon!

One of the most important decisions of recent years, in terms of cycling as a means of travel, will be made by the Council Transport Committee on Thursday 17 June. Councillors will decide whether to start the legal processes to make SfP schemes permanent (with redesigns/ enhancements) – or to scrap them.

Like cities around the world, Edinburgh took advantage of national covid one-year funding to install extensive measures to encourage walking and cycling for everyday travel. For cycling this meant 39km of semi-segregated main road routes, plus traffic-restricted routes, i.e. the basis of a city cycle network. Also, safety measures from footway widening to road closures at some 70 schools, and a fair bit of footway widening in local town centres.

This is truly remarkable when you consider the many years of delays in finalising plans and permissions for one-off schemes such as the city centre west-east route CCWEL, or even Canal-Meadows. Indeed, unlike those projects, this embryonic network was not in any forward plan or strategy – it was an immediate response to an immediate need and to the immediate opportunity of substantial but highly time-limited cash from the government.

There is a major Spokes article about how the Council could build on this, in particular...

- ◆ Creating links and extensions to form an ever-improving network
- ◆ Tackling dangerous junctions to enhance the safety and thus the usefulness of the network
- Revisiting existing Spaces for People schemes they had to be introduced rapidly, and at low cost, or they would not have happened at all. Furthermore, now that they are in place a great deal of experience has been gained. Finally, they all exist under temporary legal criteria, on the basis of Scottish Government advice to Councils, and to become permanent wider consultations and the opportunity for formal objections are necessary. For all these reasons, the schemes should and must be revisited giving the opportunity for both early and longer-term improvements and redesigns.



### What you can do...

- Read our <u>article</u>, which includes **maps** showing how the network could develop; **bike counts** on SfP routes; and many **social media postings** from members of the public (as above) who value the routes.

- ♦ Most important! if you agree with our points, email your councillors as soon as possible, explain briefly why the SfP schemes need retained, enhanced and expanded into a fuller network, and ask that their party supports this at the Transport Committee on 17 June. If a particular scheme helps you, make sure to mention that, as well as any improvements you'd like made to it.


# 4. Major area-wide consultations

"The 2018 Musselburgh Active Travel Network Masterplan proposed a network of strategic active travel routes, and three of these are currently being taken forward by East Lothian Council to the Concept Design stage. The routes will connect key attractors within Musselburgh and provide greater accessibility between Musselburgh Town Centre and surrounding communities. The project has been awarded funding through the Places for Everyone scheme, funded by the Scottish Government through Transport Scotland and administered by Sustrans."




# Low Traffic Neighbourhoods: Leith & Corstorphine - ends 4 July Consultation website

Spokes greatly welcomes these proposals which aim to create "a safer and more comfortable environment for walking, cycling, wheeling and spending time in local streets and outdoor spaces." Of course, we can suggest improvements, so do send us your thoughts as well as making your own submission.

One member has already pointed out the following for the **Leith** consultation...

- ◆ The SfP Links Gardens closure is to be re-opened it should be retained
- ◆ John's Place should be closed to through-motor traffic, to stop rat-running past Leith Primary
- ◆ A segregated onroad route is needed to connect Sandport (North Ed paths) to Leith Links (for Portobello)

### 5. Take care!!

We've recently had reports of 2 bike crashes with serious injuries. Both were to **very experienced** cyclists, one a Spokes member. Please take note of the probable crash causes below – it could help you! Spokes raises such issues with the Council (more than once sometimes!) but if you are affected, please do contact your councillor.

**George IV Bridge** This is one of the few SfP schemes still using the old kind of lane dividers where the 'wand' is very easy to remove – we suspect the occasional driver who wishes to park by the kerb does this. Once the wand is removed, it is not easy to see the small black base, but if your bike hits it, you could have a nasty crash.

We have written to the Council – they won't make any changes pending the June 17 meeting (see 1 above), when the future of all SfP schemes will be decided, but they have promised to inspect the road daily until then, to replace any missing wands. **NOTE** – it is very easy to replace these wands, and some spokes members regularly do this! One just inserts the wand into the base and then a twist should get it firmly in place.

**Haymarket Station** Tramline crashes continue here, though they are far far fewer than in the early days before the Council made a number of changes. Using the 'jug handle' lane helps you get a better angle for crossing the tram lines – do make every effort to cross at as good an angle as possible – on every journey.

You may know that the Council has <u>long-delayed plans</u> to make physical changes here (and at 4 other blackspots). The Haymarket scheme has now been moved into the CCWEL west-east cycleroute project, which means that work will probably not happen at this blackspot until autumn at soonest.

## 6. Philanthropist wanted!!

In 2019/2020, thanks to a kind surprise donation from a charitable trust, Spokes was able to offer grants of up to £1500 to Spokes member households towards the cost of a cargo bike (new e-cargo-bikes usually cost £5000+). This trust has an environmental outlook and their wish was to see more cargo bikes on Edinburgh's streets.

We'd like to offer another round of grants to Spokes member households (including anyone who joins) but the above charitable trust is now directing all its grants to covid-related work, so cannot provide another donation. # 7. Other current consultations – please respond to any that concern you

#### Aviation tax reform ends 14 June

- Currently there is no tax on aviation fuel, no vat on tickets, and sales are 'duty-free'. In contrast, when travelling by rail (or even car) you pay all these costs – despite the fact that you are creating significantly *less* environmental damage!
- The UK government is consulting on aviation tax reform. But instead of rectifying the above, it is considering reducing the one tax that does apply, Air Passenger Duty.
- The consultation is <u>here</u>. Background <u>here</u> from the Aviation Environment Federation.

#### ◆ Granton Waterfront ends 20 June

- The Council is consulting on proposals for a large area of mixed-tenure homes in a development aiming to "champion low carbon transport, active travel and sustainable development, supporting the Council's commitment to achieve net zero carbon by 2030 and the emerging themes of the <u>City</u> <u>Mobility Plan</u> and <u>City Plan 2030</u>"
- Consultation <u>here</u>. Even if you can't think of any improvements, a supportive comment might help!

# Midlothian Local Development Plan register for info

- Midlothian is working on a LDP, which covers all uses of land, including transport. A <u>revised timetable</u> is being considered, so that the LDP can take account of the drastic changes resulting from covid 19.
- You can register to be informed of opportunities for consultation <u>here</u>.


## ◆ Traffic Regulation Orders closes 30 July

- The current rules for TROs cause many problems. Some are in appendix 1 here. For example, the intolerable 2-year delay caused to CCWEL, the council east-west city-centre route, by a small number of objections which were eventually entirely dismissed by the government. Similarly, making SfP schemes permanent is going to require two legal processes (ETRO followed by TRO), on top of consultations already undertaken, instead of one single process.
- In 2019 the Scottish Government refused to accept an amendment to the Transport Bill to rectify some of these problems. However, they agreed to consult on changes, hence this consultation in 2021. Spokes will be responding but has not yet considered the questions carefully – it is complex.
- o Consultation here. If you are commenting you can at least point to the need and urgency for change.
