# 1. Spokes Public Meeting, Weds 22 Sept online ... Local Bike Campaigning

There's a flourishing of locally-based campaigns for cycling infrastructure and wider car-reduced living, supporting walking, wheeling, local public transport and places no longer dominated by the demands of the car.

Our meeting, at 7.30pm on **Weds 22 September**, hears from a range of local campaigns, together with city-wide groups BEST and Spokes, and is followed by our usual fulsome QA. We'll hear how and why groups started, the challenges, the successes and what comes next. We hope it will give *you* some ideas too!

The new campaigns have a range of local and wider motivations, but all come under a general theme of developing places and ways of getting around that are less car-dominated, safer, healthier, more climate-friendly. For example, fighting for a specific cycleroute, lobbying for a wide low-traffic neighbourhood, bike buses for safer school travel, or banning motor traffic from inappropriate locations such as Holyrood Park.

Some groups form initially to support a welcome traffic proposal, or oppose an unwelcome one. Some because an individual feel passionately that their area needs to counter the insidious growth in number, size and dominance of motor traffic on their local streets. Government allows public space to be changed in this way with zero public consultation, whereas measures to restrain the car do (rightly) have to be consulted on ... it feels unfair.

At the meeting, the following groups will speak for 5 mins each on how and why they started, the challenges, successes, what they have learned and what next...

  Transport. Whilst Spokes is very supportive of all active
  travel and public transport, our primary work is on cycling,
  whereas BEST has a wider 'safer streets' remit from the
  outset. We're good friends! Spokes is also Lothians-wide,
  whereas BEST is Edinburgh only.

To inspire you, we print a few extracts from entries below (it's optional for your photos to include a mugshot!)



#### Comments on the schemes you visited

- Comments can be as long as you like, but at least 25 words. They must be constructive, for example what you liked and/or what needs improved or changed

#### [1] EL1 Musselburgh Electric Bridge

Home turf for me this one! The bridge has been a great addition to the cycling network an is widely used. It's largely eliminated conflict between cyclists and pedestrians using the footbridge. Sometimes the blocks (which are presumably there to stop cars using it) are badly positioned making it almost single-file which is ridiculous given the width of the bridge. If it becomes permanent I hope they just use bollards instead.

[2] W4 Lanark Road

The segregation here is very welcome particularly on the uphill section. This route provides a direct route in and out of town and being relatively wide and straight it's well-suited to a segregated cycle lane in my opinion. The surface isn't fantastic though- if by some miracle they were to put in more permanent infrastructure in place here I'd hope they resurface the road first. The downhill section in particular is a bit of a <u>rollercoaster</u>.

[3] S4 Gilmerton Road

A mixture of permanent and temporary <u>SfP infastructure</u>. The permanent fixtures are all of a good standard and the road surface is (by Edinburgh standards) immaculate. The temporary sections are a mixed bags and there are sections where there is no protection. Ironically on the day I surveyed this I got both a close pass and then a left hook from a number 8 bus on one off the sections where there is no protection!


Of course, even if you don't enter, you can still get Spokes Maps and a Spokes Buff from shops or direct.

# 3. Scotland Programme for Government

The Scottish Government has just published its Programme for Government, covering next year and also up to the next election. The Programme confirms the huge rise in active travel cash in recent the Green/SNP agreement, and reaffirms the incredibly tough target to reduce car-km 20% by 2030.

Whilst Spokes greatly welcomes these commitments, we have serious concerns about the political will to ensure effective and timeous implementation, including...

- Using the new cash effectively will need urgent action to rationalise
   Traffic Regulation Order rules, tough action on roadspace re-allocation
   and upskilling of transport staff and consultancies across Scotland
- The government so far seems unwilling to adopt the kind of policies which will give it any hope at all of achieving the 2030 traffic reduction target.

## 4. Spaces for People – medics letter

An <u>open letter</u> supporting the retention and further development of Spaces for People projects has been sent to all Councillors, signed by an incredible 140 Edinburgh medical professionals, many in very senior posts.

The medics say the changes are potentially life-saving and have the twin benefits of improving public health and mitigating the climate emergency.

The letter says (in part) ...

"As health professionals, we have a responsibility to protect and promote the health of the population. We have a responsibility to address inequalities and to advocate for the needs of the most deprived and disadvantaged members of the population we serve.

"We are concerned about the impact of the climate crisis on health, globally and locally.

"We support the retention, and further development and integration of infrastructures designed to support active travel and clean air for the whole population of Edinburgh, to mitigate inequalities in health, local mobility, and air quality. We are concerned that suggested steps to reverse active travel measures introduced during the COVID-19 pandemic would be a retrograde and harmful step for the health of the population of Edinburgh."

The letter was prepared by Dr Laura McWhirter, who is Consultant Neuropsychiatrist at the Royal Infirmary of Edinburgh and Clinical Research Fellow at the University of Edinburgh. Also, we are proud to say, a Spokes member!

# SfP future [now called by the Council, 'Travelling Safely']

At its 19.8.21 meeting, the Council's Transport Committee <u>decided</u> to move to the next phase of making permanent virtually all the main-road cycle schemes. Spokes had a <u>deputation</u> jointly with BEST.

Due to the Scottish Government's dysfunctional Traffic Order Regulations (for which the long-promised review is still not complete) making the schemes permanent is very tortuous – see article <a href="here">here</a>, especially appendix 3. It will require for each scheme an Experimental Traffic Order (ETRO) followed by a normal TRO. In addition to the public consultation already undertaken, each of these 50 or so schemes will therefore require two further public consultations. We hope people will understand that the blame for this excess bureaucracy lies with the Scottish Government rather than the Council! The first set of consultations is expected in October.

Apart from the Council's major excellent decision to retain nearly all the 40km of segregated lanes (and, in the longer term, improve them) there were several serious disappointments at the Committee, including...

- Virtually all the 'town centre' schemes will go this is largely the footway widenings and also includes, for example, the much-valued uphill cycle lane on Morningside Road
- The George IV Bridge/ Forrest Road schemes goes this is because the forthcoming legal orders for the permanent Meadows-George Street scheme are out shortly, and an Order for the existing scheme is apparently not possible at the same time hence the existing scheme can't remain until construction starts. Yet another Traffic Order problem!!

### 7.1 SEStran Strategic Cycle Network, Livingston-Addiewell section – closing date soon?

<u>SEStran</u>, the South East Scotland Transport Partnership (not to be confused with Sustrans) has drawn up plans for a 'strategic, cross-boundary' cycle network linking the Councils in the area, and building on existing routes and proposals. There is currently a consultation on plans for the Livingston-Addiewell section; we do not know the closing date, but it may be soon.

There is a fancy online 'virtual engagement room' at which you can see the whole SEStran strategic map and comment on the proposals for Livingston-Addiewell. <a href="sestran-west-lothian.virtual-engage.com">sestran-west-lothian.virtual-engage.com</a>
To see the various 'info boards' in the exhibition, click the right or left arrows at the bottom of the page. To read any board, hover over the logo at the top of the board, then click on the drop-down window that appears. When you click on one of the boards (called Next Steps) you will get a short QA about Livingston-Addiewell, assuming the consultation has not yet closed.

### 7.2 Holyrood Park Road Network – ends 30 September Consultation website

NB – although within Edinburgh, this is a Historic Environment Scotland consultation, as they operate the park.

The consultation seeks your views on road closures in the Park. Before responding, we recommend reading the following...

### 7.3 Edinburgh Council Low Emission Zone — ends 20 September Consultation website

"The City of Edinburgh Council aims to reduce air pollution, since it presents a significant threat to public health. It is especially harmful to young children, the elderly and those suffering from pre-existing conditions, including heart and lung diseases.

Low Emission Zones (LEZs) are being introduced across Scotland's four largest cities: Edinburgh, Glasgow, Aberdeen and Dundee in response to dangerous levels of air pollution, primarily nitrogen dioxide (NO2), generated by road traffic. LEZs aspire to improve public health by discouraging the most polluting vehicles from entering an area. If a vehicle entering a LEZ does not meet the minimum exhaust emission standard, then a penalty fine is issued. The Zone is intended to only target the most polluting vehicles."

As with 4.4, Spokes has not yet started on a response – we welcome comments – or volunteers to do a first draft! One big concern is that the proposed LEZ boundary is only around a small very central area. This may result in additional traffic, particularly polluting vehicles, taking roads round the edges of the zone – e.g. <u>Holyrood Park</u>.

Friends of the Earth Scotland is campaigning for tougher LEZs in the four cities above.

### 8. ScotRail timetable consultation – closes 1 October

ScotRail is consulting on a proposed timetable from May 2022. Covid has meant a massive financial crisis, with passenger numbers plummeting for many months, and still way below the old normal. Moreover there are signs that future travel patterns may change, with reduced peak traffic but more passengers for leisure and off-peak.

The new timetable tries to adapt to such factors. It includes a number of changes in routes as well as timings and numbers of services - obviously to reduce costs, but also to fit better to the changing passenger patterns.

The consultation does not mention bike/rail, but you may wish to raise this – for example, whether the Oban Line will continue to have the new bike carriages, and if these will be added to the other West Highland lines and the Far North line as originally intended. If bike provision on certain lines will make you more likely to use them, it's worth saying, as if more (or fewer) people use the line this could affect the number of services in the timetable.

Note that there is only **one open-ended question**. This question appears after you have completed the tick-box question about choosing positive/negative/both. **If you wish to raise bike/rail issues, use that space!!** 

#### 9. Scottish Government consultations

Please do respond to all that concern you. Also, as mentioned in the 'volunteer' section (4) above, we'd greatly appreciate a volunteer with the time/knowledge to join Spokes Planning Group with a view to preparing draft Spokes responses to 'policy' consultations such as one or more of these.

#### 9.1 Penalty Charges for Parking Enforcement – ends 4 October Consultation page

This consultation is about toughening the rules and fee levels for some existing parking illegalities, and also setting penalty rates for the new parking offences defined in the 2019 Transport Act, and which are expected to come into effect next year – namely, pavement parking, double parking and drop-kerb parking.

Incidentally, if your editor understands it correctly, these penalties will only apply in Councils which have decriminalised parking enforcement – this includes Edinburgh, Midlothian and East Lothian, but not West Lothian, where the police have to enforce parking rules rather than the council doing so.
