The Council proposes to make an order under the Road Traffic Regulation Act 1984 as amended to: -

- Restrict waiting for 24 hours of every day and prohibit loading and unloading between the hours 7.00am and 8.00pm Mondays to Sundays inclusive on the roads specified in Part A of Schedule 1 below.
- Restrict waiting for 24 hours of every day and prohibit loading and unloading between the hours 7.30am and 9.30am and 4.30pm and 6.30pm Mondays to Saturdays inclusive on the road specified in Part B of Schedule 1 below.
- Prohibit stopping for 24 hours of every day on the roads specified in Part A of Schedule 2 below.
- Prohibit stopping between the hours of 7.30am and 6.30pm Mondays to Saturdays inclusive on the road specified in Part B of Schedule 2 below.
- Restrict waiting for 24 hours of every day on the roads specified in Schedule 3 below.
- Introduce parking places, between the hours of 7.30am and 6.30pm Mondays to Saturdays inclusive, where vehicles are prohibited from waiting for a period longer than 60 minutes (no return within 90 minutes), on the road specified in Part A of Schedule 4 below
- Introduce parking places, between the hours of 7.30am and 6.30pm Mondays to Saturdays
 inclusive, where vehicles are prohibited from waiting for a period longer than 4 hours (no
 return within 2 hours), on the road specified in Part B of Schedule 4 below
- Introduce parking places, between the hours of 9.30am and 4.00pm Mondays to Fridays and 8.30am and 6.30pm Saturdays inclusive, where vehicles are prohibited from waiting for a period longer than 60 minutes (no return within 90 minutes), on the road specified in Part C of Schedule 4 below
- Introduce loading and unloading places operating for 24 hours of every day on the roads specified in Part A of Schedule 5 below.
- Introduce loading and unloading places operating between the hours of 7.30am and 6.30pm Mondays to Sundays inclusive for a period of 60 minutes on the roads specified in Part B of Schedule 5 below.
- Introduce loading and unloading places operating between the hours of 9.30am and 4.00pm Mondays to Friday and between 8.30am and 6.30pm Saturday inclusive on the roads specified in Part C of Schedule 5 below.
