

## Garden bike storage

***The new Scottish Government rules on permitted development rights (PDR) came into force on April 1<sup>st</sup> 2021, after a [lengthy Spokes campaign](#). Below is our first subsequent happy customer!***

Hello XXXX,

We are delighted to say that our submission to Scottish Government was entirely successful. We will be allowed sheds meeting the Spokes dimensions in front and side gardens from 1st April 2021, with no planning permission required! This is under new Permitted Development Rights legislation. (Maximum size 2.5m long x 1.2m deep x 1.5m high) We are particularly pleased that the new legislation applies even in Conservation Areas. It does not however apply to listed buildings - are you by any chance living in a listed building?

We would still strongly recommend taking the measures that we recommend in our Cycle Storage in Gardens Factsheet which is to talk to your neighbours, ideally making sure that they are content with your plans, screen your shed with hedging or planting of some kind, as far as possible, and choose a discrete colour for your shed. We say this because the local authorities opposed the change in the legislation, fearing the impact on amenity, and the legislation could possibly be amended or reversed, if this fear becomes the reality! We are discussing a revision to the Factsheet to reflect this huge change.

I hope that you can hold off your plans for another few weeks, just to see the legislation come into effect, but you could be talking to your neighbours, planting screening and preparing the base in the meantime. Consider security carefully because cycle theft is currently big business and front and side garden sheds are more visible and hence vulnerable to forced entry. Locking bikes to a fixed object in the shed is vital, with the help of, say, a ground anchor.
