# subject: Consultation on Pedestrian Crossing Programme: Spokes Response

Hello Martin,

I'm getting in touch on behalf of Spokes in regards to various new pedestrian & toucan crossings being consulted on. It's always good to see new active travel infrastructure and we have attached several comments below.

General:

Multiple of the proposed crossings are adjacent to large bellmouth junctions. Narrowing these at the same time would contribute to an improved pedestrian environment through shorter crossing distances and a safer environment through slower turning speeds.

Several crossings are also proposed in existing traffic calmed areas and near schools (5, 6, 9, 10, 11 and 12). Raising these controlled crossings would provide further speed mitigation. There are several examples of this in the CEC area, notably new crossings that are currently being installed on <u>Grange Road</u>. This area had a significant speed compliance issue.

## Detailed:

Crossing 1. Crossing could be moved significantly closer to the junction. Junction radii should be reduced, particularly if kerbing work is already proposed. Given the shared-use nature to the north, the island and proposed connections should be suitable for use by cyclists.

Crossing 4. Narrowing the junction radii would allow a straight crossing to be installed with full tactiles.

Crossing 6. Particularly egregious junction layout to the east.

Crossing 7. Unclear whether suitable width exists to allow comfortable shared use facilities on either side of the proposed toucan. Footway should be widened to enable this.

Crossing 9. Opportunity to reduce new footway construction by moving the crossing closer to the desire line and reducing the junction radii.

Crossing 10. Chicanes should generally be removed, as seen in the CEC area. If chicances are to remain, they should be widely spaced so as not to obstruct those on bikes or using wheelchairs or similar. Unclear whether the proposal includes the removal of chicanes.
