# **Updates/ongoing**

# **Construction projects:**

- West Edinburgh Link
  - Construction Phase 1 started: Bankhead Drive to Calder Road. No news on funding. South Gyle Access Road
- Leith Connections
  - Signal issue at FotW & Henderson
  - McD contacted Miles (project manager) they were waiting for the bins on Gt Jn St to be relocated to bus stop area (now sorted) and some landscaping works. No info given re opening date or whether any opening "event". Still a bit of landscaping at The Shore and Dock Street but all the route is now rideable though the signals are not in use (lights are working but not call buttons.) Still unclear who is sorting out the connection at FotW). Robert Armstrong thinks it is ETYN and said he would talk to Miles but not heard anything.
- Elm Row/TtN Mitigation Measures
  - Elm Row work has still not restarted
  - Unidirectional cycling issue how to improve correct use
  - Balfour Street buffer issue MM to meet RA on site
  - O McD met Robert (project manager) minor works hoped to be finished before Christmas works recess to include bollards to protect the cycleway from parking intrusion and markings to deter cyclists from using old northbound cycleway until new flags can be sourced to change the surface.
- Queensferry High Street
  - Works on the first phase continues
- Charlotte Square Interim Scheme
  - O Still no snagging work on-site AR to chase and share the list of defects. McD has written to Marie (project manager) for clarification as to what further Interim works there may be and comments on the proposed final scheme.
- King's Theatre (Meadows / Canal)
  - O Construction starts 12.01.2026 TRO for full scheme support comment needed.
  - RA to request access / comment on compound
- Lawnmarket / Old Town Streets
  - Ped/cycle zone signage is now in place but it's incorrect and doesn't seem to be supported by an ETRO. New signage now in place for contraflow.

Princes Street:

<u>Planning Committee</u> outcome was a very pleasant surprise, which must have given the planning officers quite a shock. We need to make sure that we will be <u>involved in the next stage of discussions</u>, the 'summit' which the officers have been instructed to undertake, and the drawing up of a more comprehensive scheme, hopefully encompassing changes to the roadway rather than just the pedestrian areas. We will be asking for involvement at tomorrow's meeting with CEC.

- QR8 at Edinburgh Park Arena
  - O Diversion route for wheelers non-existent. Recent contact and response sent. On agenda for tomorrow.
- Meadows George St
  - RSO called into Scottish Ministers + Public hearing for meeting
- Voi Cycle Hire Scheme
  - Scheme has expanded zone with more bikes due 03.12.2025 @ 15:30
- Porty Junction
  - Still in the design stage. No money for Construction as yet. McD to ask at tomorrow's meeting which Design is being taken forward.
- <u>Braids Estate</u> 2026 installation now proposed

Query Canaan Lane money for One Way Street actually a footway widening scheme

  - George St difficulties turning at west end and risk of ice could barriers be widened/are
