### Updates/ongoing

#### Construction projects:

- West Edinburgh Link
  - Construction Phase 1 started: Flassches Yard to Edinburgh College + Torwood Path (~600m...)
- Leith Connections
  - Signal issue at FotW & Henderson st [*See note 2 below*] - McD A permanently on "Ahead only" arrow has been added to the bottom of the cycle signals. Observation that cyclists continue doing every conceivable manoeuvre
- Elm Row/TtN Mitigation Measures
  - Elm Row - Cllr Caldwell by end of March on BlueSky
  - Unidirectional cycling issue
  - Balfour Street buffer
- [Queensferry High Street](#)
  - First phase works should be complete. Main works due Jan'26 - Mar'27.
- Charlotte Square Interim Scheme McD: and George Street (meeting on Wednesday 21.01.2026 for a run through of the layout plans and Order drawings - DO WE HAVE THESE ALREADY??) 16th January MM email doc.
  - Still no snagging work on-site
- King's Theatre (Meadows / Canal)
  - Construction is ongoing until April'26.
  - Cycle access is still on Valleyfield Street but has been restricted/closed by the contractor at times.
  - Gilmore Place closed for resurfacing from 26/01.
- Lawnmarket / Old Town Streets
  - New signage now in place for contraflow. ETRO 2nd stage due soon.
- South Gyle Road bridge
  - The previous road bridge is currently being replaced as part of electrification works. The new bridge is due to be ped/cycle only.

  - No news on further expansion as yet, but the goal is 800+ bikes within the coming months.

  - Also update from Officers via Cllr Parker (*see Note 3 below*)
- Craigiehall estate (formerly the HQ of the Army in Scotland)
  - Seemingly limited cycle access during refurbishment works.

## Planning

- **New Bike Store in South Gyle:** A planning application ([25/06583/FUL](#)) has been registered for external alterations at **6 Lochside Avenue**. The project includes the formation of a new bike store and a re-organisation of the existing car parking and courtyard landscaping.
- **Replacement Bike Stores at Easter Road:** There is a proposal to remove "rotten and unserviceable" wooden bike stores and refuse enclosures and replace them with powder-coated galvanised steel versions. This application is for a property at **Flat 1, 1 Easter Dalry Road**. [25/06580/CLP](#)

- **New Cycle Store** at Multrees Walk (Granted): A planning permission application ([25/04989/FUL](#)) was granted on January 5, 2026, for works at 24 Elder Street and 2, 13-15, 16 Multrees Walk. The project includes replacing two existing ATM vestibules with a new cycle store that will feature a new door on Elder Street.
- **Large Housing Development in Leith (Notice Received):** A Proposal of Application Notice ([25/06573/PAN](#)) has been received for a housing development on **Land 8 Metres North of 25 Shore**. The proposal for approximately 212 units explicitly includes the provision of **cycle and bicycle storage** as part of the associated infrastructure.

### Note 1

*Robbie:* I can send feedback to Unique Assembly about the closures this year. No emergency issues but some minor: ice from zamboni George St, loose screws George St, no space to turn to correct side of road westbound George St at Charlotte Sq and Castle St, Waverley Bridge reopened before deconstruction finished. Let me know of any more.

I managed to get the first 2 suggestions for the Roadworks and Cycling datasheet to Martin, covering tram tracks and dismount signs.

Individual closures: CCWEL much improved. Resurfacing projects such as Silverknowles still poor but Active travel input on Gilmore Pl is promising. Network Management action on St Marks and Ferry Rd paths good.

I agree with Dave that our commentary on Rose St and Fountainbridge is reasonable. Living Streets still don't understand that no cycle route is intended on Rose St.

### Note 2

14.01.2026 Cllr Faccenda update: The contractor(Balfour Beattie) will carry out some final kerbing and surfacing work at the Great Junction Street end of Henderson Street on 20/21 January and this means that during these works it will not be possible to enter Henderson Street from Great junction Street but there will still be pedestrian access.

Cars will have to enter Henderson Street from Shore and there will be signs for the diversion and the bus lane camera will be deactivated.

Work will be undertaken between 0730 and 1800.

Once this work is complete Lothian Buses will be able to reinstate buses in both directions on Henderson street.

Kirkgate Bus Stop - Lothian Buses have indicated concerns about the bin hub next to the stop and work is ongoing to mitigate this and get buses stopping there. This is being treated as a priority issue.

### Note 3

*A small update on Voi parking from CEC officers:*

"On street parking is absolutely something we are looking at and I'm in ongoing discussions with colleagues in the TRO team around how we can implement this. As the point made below, a TRO could be tricky with the scheme only being a 2-year pilot scheme however we are exploring options and I expect on street bays to be implemented this year. We are looking at trialling a handful of locations (20ish) to see how the process works etc and these can then be utilised for bike parking or bike stands (if the scheme does not get extended/renewed).

As we expand out into the city we are starting to run out of suitable pavement space and I'm really keen to minimise impact on pedestrians as much as we can and if we can do that by utilising parking space or other carriageway locations then firmly believe this is what we should be doing.
